With the full conviction that Loyalty & Patriotism alone impels me, I once more take leave most respectfully to obtrude myself on your notice — if in so doing I lay myself open to censure for not applying through a proper channel for communications of this description, give me Sir, at least credit for those motives of the purest delicacy by which I have been actuated — and, if you will permit me to lay our correspondence before Lord Melbourne, or the Home Secretary I will instantly wait upon either of those gentlemen.

The accompanying book intended for immediate publication, is no doubt a coup de main to extort money and to excite the public hatred against every branch of the Royal family, the better to carry into effect the diabolical objects of the friends of Lady Plow, or Eliza, Lady Edwardina.

From the moment I became acquainted with the affair I have used every exertion to outwit the rebellious set who are thus cunningly plotting mischief, and at my own risk & expense, & I may truly say, at the sacrifice of the only property I possess, I have endeavoured to get into my possession all the original documents of the "secret history". — To gain this object, on Wednesday evening last March I descended to an interview at my house, with the wretched editor of this disgraceful book, Susan Woodward.
