In one of your Letters a Trunk is mentioned as having been left with a friend (Cott Ord) ^{Mr} what became of that trunk or the articles contained in it

In the trunk now found Papers and some of the trunk but what I have been given up

^{Mr} Did Cott Ord know the contents of the trunk left with him. Or have you seen that Gentleman since your returning to England from Provence

Certainly not further than that it contained Papers of mine I got the trunk from him on my return to England and have since had him at Naples

When you visited at Kensington did Prince of Wales look on both the Door between the attendants of Prince Charlotte and that room in which Her Royal Highness and you were some times with the Prince of Wales and some times alone with Prince Charlotte

Not to my knowledge but none of the attendants ever did come into the room

Did you receive Letters from Princeps — by any other Channel excepting that of the Princeps of Wales

Not to my knowledge

Did Her Royal Highness The Princess of Wales deliver you the Letters which you had written to Princess Charlotte or what is become of them

I cannot speak to that because I believe they were all destroyed by Princess Charlotte

Did Her Royal Highness The Princess of Wales has not delivered you the Letters as above described Did H.R.H. inform you what was become of them
