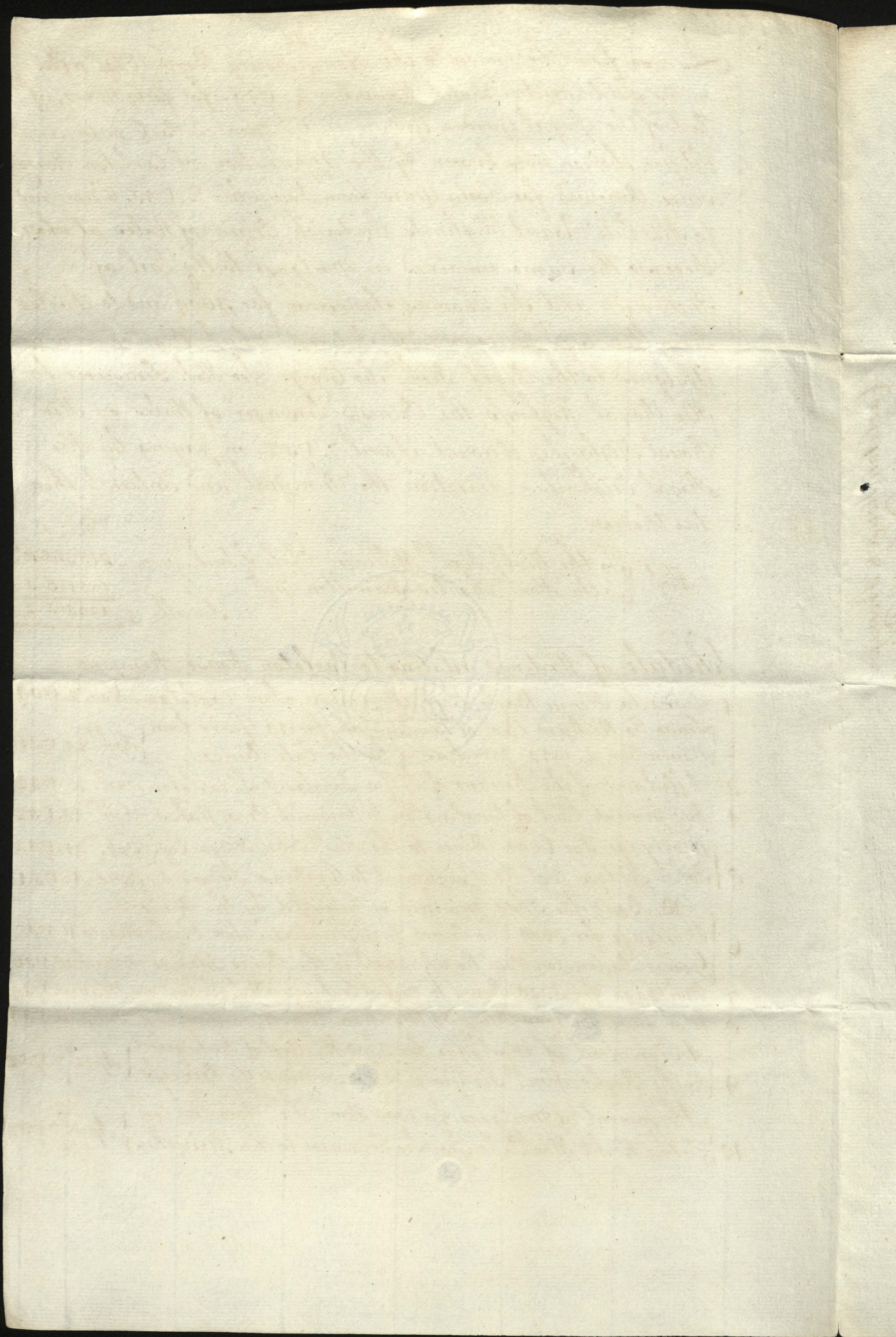


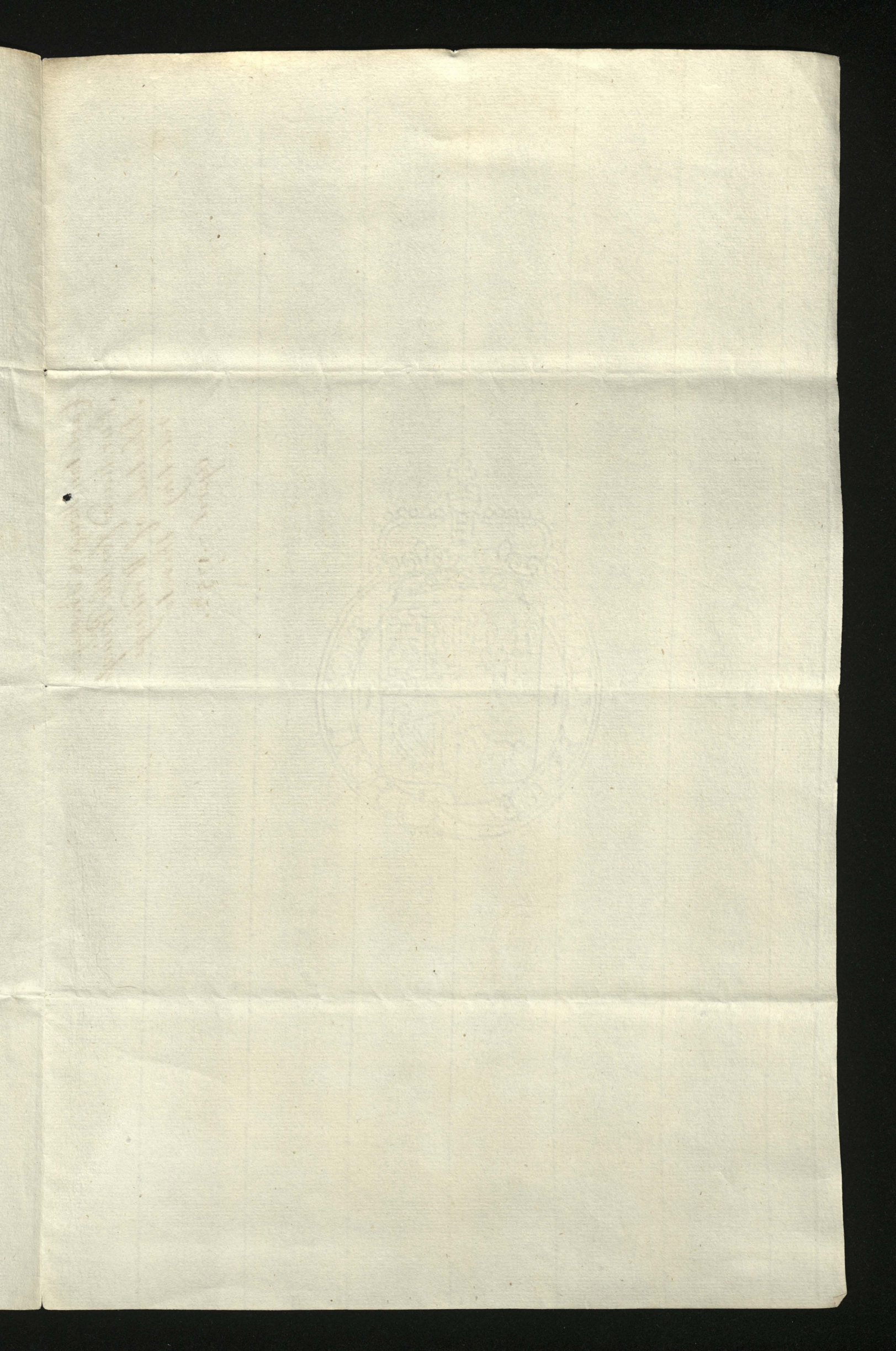
Lease from the Crown to the Hon. Henry Boyle Esq. afterwards Lord Carleton Dated November 2. 1709. for forty years, of Part of the Royal Garden Ground in S. James's Park with an Edifice thereon now known by the Appellation of Carleton House since Renewed for Forty Years from November 2. 1740. & assigned to His late Royal Highness Frederick Prince of Wales at whose Decease the same remained in Mortgage to the Earl of Inchiquin and Sir Thomas Sanderson for 3000 and to Charles Hamilton Esq. for 1000 with Interest. which Mortgage was Assigned to the Right Hon. Sir George Lee Knt. Treasurer to Her Royal Highness the Princess Dowager of Wales on Her Royal Highness's Account April 7. 1752. on paying by Her Royal Highness's direction the Principal and Interest then due thereon.
